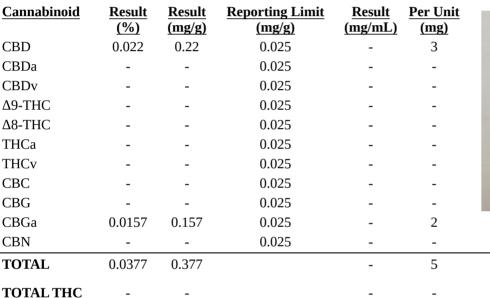
Cannabinoid Distribution
